Fall in Love with Soma Sweepstakes
Official Rules

NO PURCHASE NECESSARY. A PURCHASE OR PAYMENT OF ANY KIND WILL NOT INCREASE YOUR CHANCES OF WINNING.

1. Eligibility: Soma Intimates "Fall in Love with Soma Sweepstakes" (the "Sweepstakes") is open to legal residents of the fifty (50) United States (and D.C.) and Puerto Rico, who are at least eighteen (18) years old at the time of entry and have a computer and access to the internet. Employees of Chico's FAS, Inc., Curalate, and their parent and affiliate companies, as well as the immediate family (spouse, parents, siblings and children) and household members of each such employee are not eligible to enter or win. The Sweepstakes is subject to all applicable federal, state, and local laws and regulations and is void where prohibited. Participation constitutes entrant's full and unconditional agreement to these Official Rules and Sponsor's, Host's and Judge's decisions, which are final and binding in all matters related to the Sweepstakes. Winning a prize is contingent upon fulfilling all requirements set forth herein.

3. Timing: The Sweepstakes begins on October 9, 2015 at 10:00 a.m. Eastern Time ("ET") and ends on October 30, 2015 at 11:59 p.m. ET (the "Sweepstakes Period"). Random.org has been retained and to select the Grand Prize winner ("Judge"). Sponsor's computer is the official time- keeping device for the Sweepstakes.

4. How to Enter: During the Promotion Period, visit the Soma Facebook page and under the tab "Fall in Love with Soma Sweeps," or our Curalate Microsite <https://api.curalate.com/v2/contests/610094798>, choose a photo from the Curalate form or pin your own photo by providing a link to the image, and add your name and email address on the Curalate Form, then submit and pin ("Submission"). **All pins comprising the Submission must be identified with "sponsored ad" and the description #sweepstakes.** You may access the necessary links by visiting the Soma Intimates Facebook page (<http://www.facebook.com/SomaIntimates>) or soma.com. After filling out the required information, you will then automatically receive one (1) entry into the Sweepstakes drawing.

IMPORTANT NOTE: Any entrant who incorporates any intellectual property or material owned by a third party into his or her Submission does so at his or her own risk. Without in any way limiting, expanding or amending the "Acceptable Use Policy" policy residing on <https://about.pinterest.com/en/acceptable-use-policy> or the Soma Intimates "Website Terms of Use" residing on <http://www.soma.com/store/page.jsp?id=57> which are incorporated herein by this reference and which shall remain in full force and effect, if Sponsor is duly notified that any element of an entrant's Submission infringes upon the rights of another person and/or receives a legally valid request to remove the affected Submission from the Sweepstakes Site because of such infringement, such Submission may be removed from the Sweepstakes Site and/or disqualified from the Sweepstakes, as Sponsor may determine in its sole and absolute discretion.

Content Restrictions

- The Submission must comply with the Pinterest Terms of Service and Acceptable Use Policy;
- The Submission must not disparage Sponsor, Administrator or any other person or party affiliated with the Sweepstakes;

- The Submission must not contain brand names or trademarks other than those owned by Sponsor, which entrant has a limited license to use to incorporate in his/her Submission in this Sweepstakes;
- The Submission must not contain material that is inappropriate, indecent, obscene, hateful, tortious, defamatory, slanderous or libelous;
- The Submission must not contain material that promotes bigotry, racism, hatred or harm against any group or individual or promotes discrimination based on race, gender, religion, nationality, disability, sexual orientation or age; and
- The Submission must not contain information that is unlawful, in violation of or contrary to the laws or regulations in any state where Submission is created.

Limit: You may enter one (1) time during the Sweepstakes Period. Multiple entrants are not permitted to share the same email address. Any attempt by any entrant to obtain more than the stated number of entries by using multiple/different email addresses, identities, registrations and logins, or any other methods will void that entrant's entries and that entrant may be disqualified. Use of any automated system to participate is prohibited and will result in disqualification. In the event of a dispute as to any registration, the authorized account holder of the email address used to register will be deemed to be the entrant. The "authorized account holder" is the natural person assigned an email address by an Internet access provider, online service provider or other organization responsible for assigning email addresses for the domain associated with the submitted address. Each potential winner may be required to show proof of being the authorized account holder.

5. Prize Drawing: Host is an independent organization whose decisions as to the administration and operation of the Sweepstakes are final and binding in all matters related to the Sweepstakes. Judge is an independent judging organization whose decisions as to the selection of the potential winners are final and binding in all matters related to the Sweepstakes. Judge will randomly select one (1) potential Grand Prize winner, one (1) potential First Prize winner and one (1) potential Second Prize winner from all eligible entries received during the Sweepstakes Period, on or around the following business day. The potential winners will be notified by email after the date of the drawing and will be required to respond to the win notification within ten (10) days of the date notice or attempted notice is sent. If any potential winner of a prize cannot be contacted, fails to provide the information requested within ten (10) days, or the prize is returned as undeliverable, that potential winner forfeits the prize. Receiving a prize is contingent upon compliance with these Official Rules. In the event that a potential winner is disqualified for any reason, Sponsor will award the prize to an alternate winner by random drawing from among all remaining eligible entries from the Sweepstakes Period. Only three (3) alternate drawings will be held, after which the prize will remain un-awarded. Prize will be fulfilled approximately 4-8 weeks after the conclusion of the Sweepstakes Period.

6. Prizes: ONE (1) GRAND PRIZE: The Grand Prize winner will receive one (1) \$500 Soma Intimates gift card (gift card terms and conditions apply) average retail value (ARV) of Grand Prize \$500.00. ONE (1) FIRST PRIZE: The First Prize winner will receive one (1) \$350 Soma Intimates gift card (gift card terms and conditions apply) ARV of First Prize \$350.00. ONE (1) SECOND PRIZE: The Second Prize winner will receive one (1) \$200 Soma Intimates gift card (gift card terms and conditions apply) ARV of Second Prize \$200.00. (Approximate Retail Value (ARV) of all prizes is \$1,050 USD). Prizes may not be substituted except as provided herein at the Sponsor's sole discretion. Sponsor reserves the right to substitute a prize for one of equal or greater value if the designated prize should become unavailable for any reason. Winner is responsible for all taxes and fees associated with prize receipt and/or use. Odds of winning a prize depend on the number of eligible entries received during the Sweepstakes Period.

7. Release: By receipt of any prize, winners agree to release and hold harmless Sponsor, Host, Judge, Pinterest, Inc., and their respective subsidiaries, affiliates, suppliers, distributors,

Limitations of Liability: The Released Parties are not responsible for: (1) any incorrect or inaccurate information, whether caused by entrants, printing errors or by any of the equipment or programming associated with or utilized in the Sweepstakes; (2) technical failures of any kind, including, but not limited to, malfunctions, interruptions, or disconnections in phone lines or network hardware or software; (3) unauthorized human intervention in any part of the entry process or the Sweepstakes; (4) technical or human error which may occur in the administration of the Sweepstakes or the processing of entries; (5) late, lost, undeliverable, damaged or stolen mail; or (6) any injury or damage to persons or property which may be caused, directly or indirectly, in whole or in part, from entrant's participation in the Sweepstakes or receipt or use or misuse of any prize. If for any reason an entrant's entry is confirmed to have been erroneously deleted, lost, or otherwise destroyed or corrupted, entrant's sole remedy is another entry in the Sweepstakes, if it is possible. If the Sweepstakes, or any part of it, is discontinued for any reason, Sponsor, in its sole discretion, may elect to hold a random drawing from among all eligible entries received up to the date of discontinuance for any or all of the prizes offered herein. No more than the stated number of prizes will be awarded. In the event that production, technical, seeding, programming or any other reasons cause more than the stated number of prizes as set forth in these Official Rules to be available and/or claimed, Sponsor reserves the right to award only the stated number of prizes by a random drawing among all legitimate, un-awarded, eligible prize claims.

12. Disputes: Except where prohibited, entrant agrees that: (1) any and all disputes, claims and causes of action arising out of or connected with this Sweepstakes or any prize awarded shall be resolved individually, without resort to any form of class action, and exclusively by the United States District Court for the Southern District of Florida or the appropriate Florida State Court located in Lee County, Florida; (2) any and all claims, judgments and awards shall be limited to actual out-of-pocket costs incurred, including costs associated with entering this Sweepstakes, but in no event attorneys' fees; and (3) under no circumstances will entrant be permitted to obtain awards for, and entrant

hereby waives all rights to claim, indirect, punitive, incidental and consequential damages and any other damages, other than for actual out-of-pocket expenses, and any and all rights to have damages multiplied or otherwise increased. All issues and questions concerning the construction, validity, interpretation and enforceability of these Official Rules, or the rights and obligations of the entrant and Sponsor in connection with the Sweepstakes, shall be governed by, and construed in accordance with, the laws of the State of Florida without giving effect to any choice of law or conflict of law rules (whether of the State of Florida or any other jurisdiction), which would cause the application of the laws of any jurisdiction other than the State of Florida.
